Social Emotional Learning at School depending on each student's needs.

- Tier1 - CBA: all students have staff highlights
- Tier 2 - small group counseling, lunch brunches, small and informal. Skill based target groups - to take place during school to work on specific skills.
- Tier 3 - More individualized, students struggling at school or needing additional support for something happening at home.

Helping new families and kindergarten families adjust.
$2^{\text {nd }}$ step - new social learning program rolling out for all schools. Broken down into four units throughout the year for grades K-5. More information coming soon. $1^{\text {st }}$ of 5 -year contract with $2^{\text {nd }}$ Step, starting formally in October.

## Principal's Report: (Mrs. Ferreri)

Welcome Back! We have had a very smooth start to the school year. Consistency in school days has helped. Didn't want last year to end because it finally felt like a normal year .A great start with new members. ENews will highlight new staff members.

Update regarding board meeting. Still holding onto money from auction in 2022 because one project was an outdoor classroom. This needs to be collaborative with BOE. Required paperwork with DEC. Submitted as ROD grant thought the state of NJ. Cannot move forward with bid process until ROD grant is approved. Will not be approved until November 2023, if approved can move forward in spring. Best case scenario is that this would be completed this year school year. Will keep us posted. Watch Board Mtg 9/18 to learn about the ROD program.

We love to have data on students. 4-5 assessments score reports will be mailed on $10 / 5$. Orchard scores were very well.

This fall additional assessments for $K$ and $2-5^{\text {th }}$, this is an enjoyable process. Parents will be notified for support children receive in school to make it a great experience.
